Aligned reads from RNAseq experiment: Transcription profiling by high throughput sequencing of HNRNPC knockdown and control HeLa cells

Description

The package contains 8 BAM files, 1 per sequencing run. Each BAM file was obtained by (1) aligning the reads (paired-end) to the full hg19 genome with TopHat2, and then (2) subsetting to keep only alignments on chr14. See accession number E-MTAB-1147 in the ArrayExpress database for details about the experiment, including links to the published study (by Zarnack et al., 2012) and to the FASTQ files.

RNAseqData.HeLa.bam.chr14_RUNNAMES is a predefined character vector containing the names of the 8 runs of the RNAseq experiment. The name of each run is its accession number on the European Nucleotide Archive (ENA).

RNAseqData.HeLa.bam.chr14_BAMFILES is a predefined named character vector of length 8 containing the paths to the 8 BAM files obtained by aligning the reads from each sequencing run. The reads were aligned to the full hg19 genome with TopHat2 and then the resulting BAM file was subset to keep only alignments located on chr14.

Details

The scripts/ folder in the package contains the scripts that were used to generate the data contained in the package (note that all the data contained in the package is located in its extdata/ folder). The README.TXT file in the scripts/ folder describes how to use those scripts to re-generate the data.
